At 8:15 A.M., Japanese time, the bomb (code-named “Little Boy”), exploded 650 yards above the city, obliterating ten square miles of the city and killing about 100,000 people. Many more would die over the next few months from burns and radiation poisoning.

Three days later, a second atomic bomb, code-named “Fat Boy,” was dropped on Nagasaki, a major naval and armaments center in western Kyushu. Containing a more powerful plutonium core than that used in “Little Boy,” the Nagasaki bomb killed approximately 75,000 residents.

President Truman maintained that the decision to drop the atomic bomb was supported by all of his advisors and was used to hasten the surrender of Japan and to avoid casualties. Shocked by the ferocity of Japanese suicide attacks, Truman hoped the bomb would force an end to the war. An Interim Committee appointed by Truman in May 1945, and headed by Secretary of War Henry L. Stimson, had recommended that the bomb be used against the enemy as soon as possible and that it be used without prior warning against a military target to demonstrate its destructive power. In his memoirs Truman stated: “Let there be no mistake about it. I regarded the bomb as a military weapon and never had any doubt that it should be used.”

Earlier in July, Japanese leaders had rejected the Potsdam Declaration, which called for unconditional surrender, and on July 28, Radio Tokyo reported that Japan would continue to fight to the bitter end. Not a single Japanese unit had surrendered during the entire war. Truman’s military advisers estimated that an invasion of Japan’s home islands would cost between 500,000 and 1,000,000 Allied casualties. The development of the atomic bomb had cost the U.S. over \$2 billion and provided Truman with the “winning weapons.” Defenders of President Truman’s decision to use the bomb stress the military reasons for employing it against the Japanese.

Yet, some opponents of the President’s decision maintain that Japan had lost the war and its leaders were about to surrender anyway. Other critics argue that the bomb was used not for military reasons, but rather for diplomatic ones (“atomic diplomacy”), as a means of intimidating the Russians, who were challenging American hegemony in Europe and elsewhere. The deep abhorrence toward the use of nuclear weapons has influenced many people today to criticize Truman on moral grounds for using it in the first place. Even in 1945, critics, including many clergymen, spoke out publicly against the use of nuclear weapons, saying they are inhumane and likening them to the poison gas used in World War I.
